THE LEASE AGREEMENT WAS TERMINATED IN SEPTEMBER 2017 AND REPLACED BY A NEW LEASE BETWEEN LOTUS VILLAGE DEVELOPMENT, LLC, A WHOLLY OWNED SUBSIDIARY OF LOTUS ENDOWMENT FUND, INC., TO FACILITATE THE REDEVELOPMENT AND FINANCING OF NEW FACILITIES CURRENTLY UNDER CONSTRUCTION FOR USE BY SUNDARI FOUNDATION, INC. DBA LOTUS HOUSE. PENDING COMPLETION OF THE REDEVELOPMENT, LOTUS ENDOWMENT FUND HAS PROVIDED REIMBURSEMENT TO SUNDARI FOUNDATION FOR TEMPORARY FACILITIES IN THE FORM OF A GRANT TO PAY RENTAL MONIES FOR THE SUBSTITUTE PREMISES.
